In 2012, Chicago voters approved a referendum authorizing the City to seek lower electricity rates for residential and small business ratepayers. After receiving prices and service qualifications from retail

electric suppliers, the City negotiated a competitive supply rate with Integrys Energy Services, Inc.

■ What if my business is not in the 0 to 100 kW delivery class?


